

## 13 January 2012 - Arizona Archives Alliance Meeting

Board members present: Christine Seliga (ASH – Tucson), Dennis Preisler (Historian), Jonathan Pringle (NAU Special Collections), Libby Coyner (ASLAPR)

- 1. Motion to approve minutes Christine. Move Dennis. Approved
- 2. Treasurer's Report Jonathan.
  - a. Balance of \$12,405.41.
  - b. Chris Marin do board member pay membership fee? Dennis says yes.
  - c. Discussion of getting a debit card for the account. Jonathan will go ahead and apply, Dennis will put it on the agenda for March meeting.
- 3. End of Year Giving Report \$690. A few more added. Made over \$700 with about \$100 worth of mailing.
  - a. People had option to check where money went.
  - b. Most money went to Arizona State Archives, which indicates that most people are interested in supporting ASLAPR.
- 4. Cultural Health Inventory Project Laraine Daly Jones. Not able to make it.
  - a. Dennis willing to work with Steering Committee for Arizona Connecting to Collections.
  - b. Nobody present knows much about Cultural Health Inventory Project, so need to wait until later date to discuss.
- 5. Budget healthy budget.
  - a. Budgeted \$650 for symposium, but not going to use that much.
  - b. History Day Award.
  - c. Melanie asked for \$150 for snacks for Summit, which we'll do.
  - d. Web hosting fee \$17/year. Dennis will get rid of other website.
  - e. Libby will talk to Jim or Melanie about money to State Archives. Up to \$1000.
  - f. AAO Hosting Fee use grant money for this.

  - a. Workshop on Copyright February 24 at ASU Hayden Library.
  - b. Dennis will do mailing, we'll advertise at Summit,
  - c. Technical logistics ask about microphone, cables, computers, etc.
  - d. Is it possible to record it? Stream it? Ask at Archives Summit.
  - e. Chris send email to Phoenix Public Library librarians.
  - f. Libby Arizona Association of Law Librarians.
  - g. Libby will do write-up/brochure.
  - h. Next ideas pose the question at the Summit (Rebekah). Dennis will bring it up in the session.
- 7. Discussion of AAO/AZAA partnership.
  - a. Jonathan steering committee is still discussing.
  - b. Dennis we have \$500 available for hosting. Need to discuss to see how else we can help.

  - b. Silhouette of Arizona, something kind of square that could go either horizontal or vertical. No books!
